## **Background**

Regional Anti-Corruption Initiative (RAI) Summer School for Junior Anti-Corruption Practitioners in South East Europe (SEE) was originally initiated in 2005 as a way to build and strengthen capacities of anti-corruption bodies in the region and to provide a platform for young practitioners to learn new practices and to exchange experiences. The School was subsequently launched in 2006 as a forum for exchange of ideas and practices among young judges, prosecutors and investigators<sup>1</sup>.

Organization of the School 2020 is envisaged by RAI Working Plan (2018-2020), and it is in line with the commitment set up in the RAI Strategic Document, particularly aimed to strengthen investigative capacities of criminal justice institutions by fostering interagency co-operation and joint investigations.

## **Objectives of the School**

General objective of the School is to provide a platform for young practitioners to learn new practices and to exchange experiences.

There are number of objectives geared towards general objective:

- Transfer new knowledge and innovative approaches by choosing selected topics in the field of prevention and fight against corruption
- Share experiences and good practices on the mechanisms for promoting integrity in the profession
- Build junior professionals' capacity and therefore add capacity of their respective institutions, and
- Build regional relationships, thus consolidating regional cooperation.

## **Format of the School**

Due to the COVID-19 outbreak, this year's, 15<sup>th</sup> Edition of the traditional School will be organized in a virtual format, following the same objectives, similar content and methodology with slight modifications imposed by the new circumstances. The School will offer 4 webinars in 2 weeks in October, 2020 as interactive lectures and opportunities to engage with the professional practitioners, including a *tour-de-table* session for exchange of good practices among the young practitioners. Participants will be provided with presentations from honourable experts in the areas of prevention and fight against corruption and on specific topics such as: corruption risk assessment, corruption proofing of legislation, integrity and conflict of interest, whistleblowing,

asset declarations and on investigation, prosecution and adjudication of the corruption cases and asset recovery. In parallel, participants from the judiciary will share experiences and best practices in the field of integrity risks and how to improve the judicial integrity as a precondition for efficient and independent prosecution and adjudication.

## **Target audience / Participants**

In order to ensure valuable exchange and interaction, the participation will be limited to 39 participants. In order to take part in the RAI School, participants will have to meet the following criteria:

- Be a junior practitioner - up to five years of professional experience as judge/prosecutor/in the anti-corruption body;
- Not have attended any previous editions of the Summer School;
- Be proficient in English language (working language of the School).

Target participants will be young representatives from Albania, Bosnia and Herzegovina, Bulgaria, Croatia, Georgia, Kosovo\*, Moldova, Montenegro, North Macedonia, Poland, Romania, Slovenia, Serbia.

There can be a maximum of three representatives from each jurisdiction. Suggested profiles: two representatives from **national judiciary (one judge, one prosecutor)** and one participant from **anti-corruption bodies**.

Participants will be selected through RAI Steering Group members. The participants are obliged to attend all 4 webinars in order to obtain the Certificate of Attendance.

Participants will be provided in advance with the relevant materials and with a Guide for Users of the webinars.

## Webinar Four: Disclosure of conflict of interest/ Financial disclosure for judges and prosecutors

**Objective:** The webinar will enable the participants to obtain advanced knowledge on the latest developments and practice in the field of integrity of judges as a key mechanism for effective prosecution and adjudication of the corruption cases. Judges and prosecutors should display the highest ethical standards in their professional and private life as well to act and to be perceived as independent and impartial in line with the ECtHR case-law. Many corruption risks can occur during processing the cases and judges and prosecutors should be aware and be able to resist to any internal and external influence on the decision- making process. The participants will be able to discuss the most important issues related to the asset disclosure, the content, the scope, the publicity of the asset declarations and the safety of judges as well other issues related to the balancing of the principles of transparency and accountability and independence of judges on the other side. The audience will be introduced with the comparative review of the GRECO recommendations related to the prevention of corruption of judges and prosecutors.
