AGENCY STATUS

- Established by the Law on Agency in December 2009 as an independent and autonomous administrative organization that reports to the Parliamentary Assembly of Bosnia and Herzegovina;
- Management of the Agency appointed in July 2011;
- The Agency is responsible for prevention of the corruption and fight against corruption in public institutions and private sector;
- The Agency has no operations and repressive authority.



SCOPE OF THE AGENCY

The Agency is responsible for prevention of the corruption and fight against corruption in public institutions and private sector.

Agency activities:

- adoption of anticorruption measures ,
- making recommendations and instructions,
- giving opinions,
- initiatives.

STRATEGY FOR THE FIGHT AGAINST CORRUPTION



- The Council of Ministers on 24 September 2009 adopted a Strategy for the Fight Against Corruption (2009-2014) and Action Plan to implement the Strategy;
- Management of the Agency appointed in late July of 2011, Decision came into force on 10 August.

GENERAL PURPOSE OF THE STRATEGY FOR THE FIGHT AGAINST CORRUPTION



- Reducing the level of corruption;
- Creating a strategic framework and common standards to be used in BiH;
- Strengthening trust in government institutions at all levels.

OBJECTIVES OF THE STRATEGY



- To establish an efficient system for coordinating activities of BiH authorities to combat corruption;
- To establish a system to prevent corruption in all structures of public institutions in BiH in order to minimize the risk of corruption;
- To build the capacities of the bodies to fight corruption at all levels of government;
- To raise awareness of society in general as well as of specific professional groups and associations about the risks of corruption.

THE RISKS OF IMPLEMENTATION

- Slow establishment of the Agency;
- The impact of policies on the work of the Agency;
- Arrears institutions
- The lack of structure and procedures for policy coordination

ACTION PLAN FOR THE IMPLEMENTATION OF THE STRATEGY (2009-2014)



- Five key specific measures:
 1. Building capacity of the Agency,
 2. Prevention of corruption,
 3. Education, training and public awareness,
 4. Law enforcement,
 5. Coordination and implementation of strategies.

ETHICAL CODE OF CONDUCT



- Adoption of Code of conduct for public administration,
- Delay in the implementation of the Action plan for the implementation of the Strategy for the fight against corruption,
- Harmonization of regulations on all levels of government,
- Role of the Office of coordinator for public administration reform in BiH.

CONCLUSIONS



- The agency will coordinate activities in the prevention of corruption at all levels of government,
- The agency will help institutions to build capacity to ensure the highest accepted standards, best practices and appropriate education,
- The agency will promote the implementation of ethical codes of conduct.
