#### ADDRESSING GAPS IN THE LEGISLATIVE FRAMEWORK FOR PROTECTION OF WHISTLEBLOWERS

Gap Analysis of Whistleblower Protection Laws in the Western Balkans and Moldova and Model Provisions for Whistleblower Protection Laws to support the enhancement of whistleblower protection laws in line with the EU Directive on Whistleblower Protection.



Gap Analysis with Model Provisions, as well as training, were identified by public institutions as most useful technical support.



#### CAPACITY BUILDING OF PUBLIC **INSTITUTIONS AND CSOS**

**200** representatives of public institutions and CSOs trained from the region;
