2. Evaluation

Candidates' applications were evaluated using a cumulative analysis method taking into consideration the combination of the applicant's experience, and qualifications. Details on evaluation criteria are laid down in the Open Call.

During the evaluation of received proposals, it has been noted that:

- Number of applications that comply with the formal requirements of the call: 6 (six);
