BERLIN PROCESS IN SARAJEVO

A HISTORIC STEP IN THE FIGHT

Sarajevo hosted a landmark regional event today within the framework of the Berlin Process, dedicated to anti-corruption and the advancement of integrity systems across the Western Balkans. The gathering brought together ministers, international representatives, experts, and civil society, creating a dynamic platform to exchange experiences, share best practices, and explore innovative tools in the fight against corruption.

Held in Sarajevo, the anniversary event brought together high-level officials, representatives of RAI member states, international partners, and long-standing friends of the Initiative. The gathering served as both a moment of reflection and a renewed commitment to collective efforts in advancing integrity and good governance across the region.

A Landmark in Integrity Cooperation: The International Treaty on Exchange of Data for Verification of Asset Declarations

Guided by RAI and supported by key international partners, this achievement reflects years of sustained regional cooperation, from the first signatures in 2021 to the ratifications that enabled full implementation in 2025. Through continuous dialogue, technical work, and political engagement, including regional workshops between 2015 and 2019 and commitments made at the Western Balkans Summit in Trieste: the Treaty now stands as a testament to Southeast Europe's ability to jointly shape ambitious, pioneering integrity standards.

Methodologies & Digital Tools

RAI has prepared methodologies and several practical and data-driven tools that help governments and institutions strengthen transparency and accountability.

Among its key innovations are:

- **Corruption Proofing of Legislation Methodology:** This involves an IT-supported mechanism that integrates integrity safeguards into the law-making process.
- **Corruption Risk Assessment in Public Administration:** A methodology and digital tool have been implemented in Bosnia and Herzegovina and Montenegro to identify and mitigate systemic vulnerabilities.

Through these instruments, RAI has helped member states modernize their prevention frameworks and align their efforts with international standards and EU requirements.

Looking Ahead: The Next 25 Years

As RAI marks its 25th anniversary, the Initiative looks ahead with renewed energy, purpose, and commitment to its founding values: cooperation, ownership, and trust. In the coming decade, RAI will focus on:

- Consolidating organisation
- Expanding digital tools and data-driven prevention mechanisms for at-risk sectors;
- Advancing regional cooperation in asset recovery and financial investigations;
- Empowering youth and new leaders through education and innovation;
- Fostering inclusive governance through stronger collaboration with civil society and the private sector.
